Insurance \\
- Public Liability Insurance covers our legal liability against \(3^{\text {rd }}\) party incidents, and Employers liability insurance to covers our legal liability against volunteers. Volunteers are NOT covered by insurance. If a volunteer is injured under an activity managed by the Bailies, the insurance covers the Bailies for say our negligence. The volunteer would need to sue / claim against our insurance. It doesn't cover the volunteer it per se. PS to revise Induction wording \\
- We can get Personal Accident Insurance to cover all issues but we need Accident Report process in place to better record incidents. Do we have any history of previous accidents/incidents? JH to enquire on premium costs. (10 work parties of 10 people, 10 digs of 10 people, wildlife? \(\approx 400\) person days). PS to develop incident reporting process \\
- FLS permit is now not unlimited but capped at \(£ 5 \mathrm{~m}\) maximum cover. Permit still to be reissued. Cover for minister's (government) property not capped
